## When Will We Go Back to Church?

Dave Thomas, Safe Reopening of Church Committee Chair

This is a question we ask ourselves every week...when will we gather, when will we worship, when will we have fellowship, when will we see our friends.... when?... when?... when? Several months ago we put together a committee to figure out how do we safely reopen and when do we reopen.

We have Dr. Jon Horstmann as our medical director, Nancy Horstmann, Shannon Nolin, Mary Bolaños, James Welte, Sandy, Wendy and myself as this committee.

Our Committee goals are to monitor the number of infections and deaths weekly in San Bernardino County and base safe reopening on the recommendations of the Governor, the CDC and Public Health Department.

At this time, meeting inside is not permitted. Indoor worship has the highest risk of infection to our congregation, many of which are in high risk groups already.

It is the recommendation of the Committee that when we do meet, we will gather outside in Magnolia Court. We will have social distancing between family units, mandatory mask use, hand sanitizer and other safety precautions in place. We will also have temperature checks and a short health evaluation prior to entering service to make sure things are as safe as possible.

We have been working diligently on a Covid19 Code of Safe Practices for FPCSB which addresses safety for Worship, the office personnel, the food ministry, the interns and other activities. With the help of Marilyn Kraft's computer knowledge, this document has become over 30 pages long. We hope to have this document available to you within the next couple of weeks.

As far as when we will reopen, we are looking for the time when San Bernardino County moves off of California's "Watch List". A variety of factors needs to occur for this to happen such as decrease of infections, hospitalizations and deaths. We are not there yet.

Over the next few weeks the Deacons have agreed to conduct a phone survey with our Congregation to find out how many people would be interested in attending a worship service with safety precautions in Magnolia Court and how many people would feel safer worshipping at home. You can help us tremendously by responding to this critical survey. We also plan on continuing to conduct online services for people who feel safer staying at home.

Many other issues are being worked out such as music with the help of Curtiss and William, sound board operations, videotaping with Raymond as well as worship service particulars with Sandy, Wendy and many other things. I wish to thank everyone that has offered their opinion and recommendations.

Anyone who has a question about anything Covid19 related is free to contact Dr. Jon Horstmann or myself. We are both well versed in the current recommendations and will be happy to answer any questions you may have.

Thank you to our congregation for your patience and understanding with these difficult issues. We will have more information in the coming weeks.

## Clergy Renewal FAQs

**What happens to the ministry?** *The ministry of this congregation belongs to us all- not just the pastor! So one of us will be away, but the rest of us will continue to try to show in our lives the love and justice of Jesus Christ. Session committees will continue to move forward projects connected to our buildings, education and nurture, worship, and stewardship. Deacons will continue to help show love in service. We will continue to love one another and love our neighbors and so the light of Christ will continue to shine in this place!*

**Who will take care of us?** *Pastor Wendy Lamb and Pastor Steve Smith will continue their ministry among us. The pastoral care team and prayer team will continue their work of love and supportive contact. The staff will continue their work and are available to answer questions and assist.*

**Who will preach?** *We are re-assembling a list of pulpit supply guests who will help us hear the Word each week in worship by means of sermon and reflection. Some will be familiar voices and faces. Others will be new friends. Additionally, Pastor Wendy will continue to preach occasionally throughout the season.*

**Can we contact Sandy?** *The folks who administer these grants have learned a lot by supervising hundreds of them. One of the things they are clear on is that it is the **sustained** and **uninterrupted** rest that makes it work. The pastor will not be reachable during the renewal leave. This will be difficult, but doable.*

**Yes, but what if...?** *Unexpected things will surely come up. We will figure them out one at a time, with God's help.*

**What's in it for us?** *An invitation to seek God in the natural world this fall, and experience afresh our belovedness. An opportunity to remember who we are when the pastor is not around. A chance to hear other preaching voices, and so hear God's voice in a new way. Funding for the pastor's refreshment and renewal. Funding for the congregation's needs during the leave. The possibility of Sabbath Joy.*

While Pastor Sandy is on sabbatical, it is important to remember that the Session is “in charge” (though we remember God is really in charge!) In the Presbyterian Church, it is the ruling elders and the teaching elder (pastor), who together oversee the life of the congregation as a Session. At any time, and especially this fall with Sandy on sabbatical, questions, comments, or concerns can be taken to any current Session member (listed below) and she or he will take the message to the appropriate person. You may also call the church office, the pastoral care team, and Pastor Wendy.

In our congregation, Session is organized into four committees that cover various aspects of the life of the congregation: Nurture, Financial Stewardship, Building and Grounds and Worship. Additionally, the Nominating Committee is hard at work and the Personnel Committee is always available if something comes up. Ideas or questions concerning particular areas can be taken to members of the specific committee. **Nurture Committee:** Oversees all aspects of discipleship and spiritual development of our congregation, specifically overseeing the Christian nurture of our children, youth, and adults.

**Financial Stewardship Committee:** Oversees all aspects of the financial health of our congregation and oversees the fall Stewardship campaign.

**Building and Grounds:** Addresses the many issues of being good stewards of our property and campus.

**Worship Committee:** Oversees all aspects of our corporate worship, including Sunday morning worship and special services throughout the year, such as our Advent and Lenten quiet nights, Ash Wednesday, Maundy Thursday, and Christmas Eve services.

## Session Synopsis

Your Session has been meeting every two weeks during the pandemic so that we can stay on top of events as things change rapidly and we don't see each other each Sunday. Plus, we love being together at our Zoom meetings! Each meeting begins with prayer and a time to share. When Sandy brought us a Tennyson poem that read, in part, "closer is God than breathing and nearer than our hands and feet" it was easy for members to describe where we had seen God recently - in a meteor shower, a poem of grief for a friend when words wouldn't come, acknowledgement and encouragement during the difficulty of caregiving, gratitude for all in our lives who pick up the slack, a trip to the Sierras, swimming pools and so much more.

With our gratitude in mind we got down to business. The Safely Gathering Committee has developed a protocol for all gatherings at the church including worship and small groups. These guidelines will be available to the congregation soon. Our responsibility in making the House of Welcome a safe and hospitable place has been met with such enthusiasm! Rooms 11 and 12 are almost complete for overnight guests. The space at 1875 D Street has been deep cleaned, examined by the Building and Grounds Committee and power cleaned outside by James. The Sanctuary Reconfiguration Committee has found the perfect seating and is working on how to best make the necessary changes to flooring, etc. The waterproof coating of the classroom roofs has been completed and a date for doing the same to the Chapel has been set. The Nominating Committee has begun the discernment process as we listen for those who might serve as Elders and Deacons for the next term. Sandy will begin her sabbatical soon and she and Wendy have been working to make sabbatical meaningful for the entire congregation as we lean into rest and renewal.

Our meetings close as we express where we have seen, felt or heard the Spirit during our time together. This time sometimes brings tears, sometimes laughter, and, often, nods of agreement. One of the blessings about serving on Session is that there has never been a meeting where God's presence has not been felt.

## House of Welcome Update

When you want something done...ask teenagers! The House of Welcome got two huge boosts recently from energetic and creative young people.

Under the supervision of Rick Rodriguez and Dan Direen, six interns spent a sweltering morning equipping the HofW to extend hospitality to newly released asylum seekers. One group joined Dan and moved a large refrigerator and small refrigerator, donated by Shelby Obershaw. They had to remove doors and tackle stairways but got the job done. They also moved the sofas from room #11 to the HofW. Rick guided the other four interns as they unpacked bed frames and mattresses, read directions in Swedish, Japanese and English and completely put together three twin beds! Watching this group work together with such enthusiasm, laughter and teasing was a gift.

Another gift was the offer of help making the HofW more welcoming and homelike by three Girl Scouts who are working towards their Silver Award. To earn this award the Cadettes have to identify an issue they care about, design a project, make a plan and put it into motion. The project must be sustainable and must benefit their community. Our Girl Scouts (Kendra Lamb, Breanna Nord and Brooke Rodriguez) have chosen to paint one of the HofW living rooms a fresh welcoming color, perhaps including a mural and to create a space in one of the small rooms where the guests can play games, read or sit in quiet. All of the girls attended the congregation Zoom with the Organizer from the Immigrant Accompaniment Ministry and are excited to get started.

Blood donation activities are NOT classified as a gathering, but rather, are an **essential healthcare service**.

Donors are only in collection areas for the duration of the donation process.

## Sign-up and Save a Life: Blood Drive

### STEPS WE'RE TAKING



**Only healthy people are encouraged to give blood.**

Donors must be feeling well and free of respiratory illness symptoms, including fever, to be eligible to donate. People who meet certain travel and other at-risk criteria for COVID-19 are deferred ahead of time from donating.



**Pre-Screening Before Donors Come In**

We have implemented screening processes including temperature checks **BEFORE** the donor walks into a donor center or mobile drive.



**Social Distancing**

We are spacing chairs 6 feet apart in waiting and donation areas.

We are limiting the amount of people permitted in the donor centers and mobile drives. We may ask you to leave a mobile phone number and wait in your car until your turn is called.

#### Our Staff Protocol

- Our staff wear gloves and personal protective gear; they wipe down donor-touched areas often and after every collection using a disinfectant.
- Staff use sterile, single-use collection sets for each donor and scrub the donor's arm for 30 seconds before the collection.
- We are requiring staff to self-monitor, including temperature checks, to ensure they are healthy before arriving to work.
- Staff who don't feel well are required to stay home.
