Pastor's Annual Report for 2021

We are living in an era of transformation. We can see it in our national politics, in global relationships, and in changes in the natural world, like wildfires. Big change is afoot!

The Church is no exception: what "church" looked like in the United States in the 1950's is changing, the forms are passing away. We know this: churches are by and large older and smaller than they once were, and engage a much smaller percentage of the population. This is not to say that the Spirit is not at work, just that how we have done

church and the structures we recognize are dying. While death brings grief and a loss of the familiar, we *know* that with God death is the doorway to new life and resurrection. In fact, Resurrection is necessarily preceded by death! As I consider 2021, I notice changes everywhere, and I remember how much I dislike change ©.

I also find myself curious and hopeful about what it will mean for us to be followers of Jesus in this unfamiliar territory.

I think, as a congregation, we are in a <u>very</u> liminal space and time. We are in the cocoon phase- in the uncertain transition between what was familiar and what we are becoming. I am holding some questions as I pray my way into 2022:

★ How are we being changed by those who are leaving?
We are losing people who have been at the very center of our common life for years- Carol Valentine, Lynette DuClos Adelson, Sally Morris, Melodee & Larry Kistner, and the list goes on. Some depart to another zip code, others for a Farther Shore. It is hard for me to imagine our staff, our fellowship, our session, or our choir without these leaders who have so embodied the love of Jesus in our midst. Whatever we become, we will not be 'the same'. Where will the spirit of Jesus meet us and guide us in this

chapter so that we can grieve, and then rise from our sadness and thrive?

- ★ How are we being changed by different relationships to our buildings? Two years ago in my annual report I said that buildings were the "bane of my existence" as they needed so much care.

 And now? Now I am excited about things that have shifted!
 - +We have sold 1875 North D St. which not only removes the mental burden of ongoing stewardship of an empty building, but removes annual expenses of about 12K/yr that we've had to spend on (utilities, security system, gardening, and taxes). Will this create new freedom and energy? I suspect it will.
 - + a new Child Care Center will open soon on our campus. We are building a new partnership with Jennifer Carter, owner of Oak Tree Learning Center. They picked up their keys in the first week of January and are now officially our roommates. They are beginning by using just the office (Room 7), then as their new license is approved and families enroll, the center will open. First an infant room (perhaps in the fall?), then they will expand from there. Spiffing up and restoring the rooms that have stood empty has been important. Creating order and cleaning and clearing out and letting in fresh light has had spiritual implications- it has led to inner gladness and hope! We are making space for something new, which is inherently hopeful.

How are we being changed by those who pass through our doors?

And 4 sets of interns from LifeSkillz were part of our common life in 2021. When friends like this come and work alongside us, it is a gift. If we are wise, we learn from them! I think we are rarely changed by facts or information. We are most often changed by stories and relationships- this is how God touches and changes

hearts and attitudes. So I wonder, what is God saying to us, and how are we invited to grow?

One last question.

★ In all the change and unfamiliarity, in all the transition and incipient newness, how can we stay attached to God rather than to our plans?

You all know I dearly love the "decency and order" Presbyterians are known for- I like making plans and having direction and all the rest of it. But the pandemic has been a good reminder that the Life that holds me up and the Love that gives my life meaning is not, in fact, located in my precious plans. It is located in the heart of God- the deep and abiding love that no drama and disruption can destroy.

So friends, thanks be to God for sustaining us. Let us walk into this time of transformation full of curiosity and hope, for the One who has called us is faithful.

Commissioned Local Pastor 2021 Annual Report

As commissioned Local Pastor, I serve as one of the pastors of this congregation. I work parttime. Each week, with Sandy or any other preacher, I work on the order of worship; I edit the monthly newsletter; I am part of the Nurture Committee, and I lead some classes. I preach occasionally and do whatever else comes up for me.

Luke 5:5 Simon answered, "Master, we have worked all night long but have caught nothing. Yet if you say so, I will let down the nets." Isaiah 43:19 I am about to do a new thing; now it springs forth, do you not perceive it? I will make a way in the wilderness and rivers in the desert.

What is the new thing God is doing? How can a new thing spring forth from getting back in the boat? What can we take from this year? What's next?

In some ways 2021 was more challenging for me than 2020. In 2020, we had to figure things out. In 2021, they kept changing and we had to change with them. Pivot! Pivot! Pivot!

The newsletter seems ever more important as a way to be in communication with one another since we aren't really bumping into each other in the halls. I have been trying to time this better so that I am working on it in the middle of the month, and it comes out before the beginning of the next month so people get plenty of notice about things. I see it as a longer-form communication than the weekly announcements, a place to include the *why* of what we are doing along with the who and where and when. It's a significant part of my ministry that I don't always talk about. I appreciate all those who send in articles and information for the newsletter and encourage it from all involved in our community life.

Whether we were livestreaming, meeting outside, meeting in the Fellowship Hall, or meeting in the Sanctuary, the Spirit was and is present. Notes from people were helpful in remembering that the Spirit still drew us together even when we felt so far apart. Coming back into the sanctuary for the first time for Sally Morris' memorial service was a holy and hard thing.

Our youth Zoomed together in March and April to plan a worship service for youth Sunday. They filmed themselves and I put it together.

It was an encouraging service of music and Word. We also had a confirmation class in the fall. It was a bright group of students, all of them asked thoughtful and significant questions, responded to scripture, and wrote statements of faith. All seven students who were

eligible chose to attend the class and were confirmed. It was a good day.

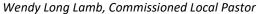
Caden Eckert spent the year as our intern. I helped shepherd that process. The conversations on Thursday mornings were enlightening to me, hearing the perspective of someone from a

Stewardship Committee Annual Report 2021

The Stewardship Committee oversees all aspects of the financial health of our congregation and oversees the fall Stewardship campaign.

2021 presented many challenges and opportunities for the Stewardship Committee as well as FPCSB, as a whole. God showed up in many ways, including:

- Child Care Center As the decision was made to close the Child
 Care Center due to Covid, we were presented with a non-debt
 producing facility (but also non-income producing facility).
 Prayerfully, we considered many possibilities. Late in 2021, the
 Oak Tree Learning Center proposed to lease, staff and maintain
 the property. This removed the financial obligation which we
 had incurred during the past few years as enrollment dwindled
 and the center was no longer self-sustaining.
- Pledges For most of 2021, church services were streamed online through YouTube. This meant offering plates were no longer passed through the pews and we had to rely heavily on mail-in, drop-off, or direct deposit offerings. Communications through newsletters, direct mail, and personal presentations to the congregation resulted in generous donations of faith. God spoke, members listened, and though the pandemic affected many financially, those who could, increased their giving. We were able to end 2021 with a slight deficit; however, not nearly the anticipated budget shortfall.
- Every member of the committee contributed lovingly of their gifts and talents. This year was faced with optimism and a "can do" attitude by all. When we asked, "Will we be able to meet our obligations?" committee member contributions included ideas, writing abilities, and historical knowledge.

In 2020 FPCSB requested and was granted an \$85,000.00 PPE government-backed loan, which allowed us to continue operations, as well as keep on staff the FPCCC employees until the decision was made to regretfully close the Center. The loan was forgiven in 2021. That, along with the substantial pledges and gifts of our members,

contributed to the relatively positive financial position of FPCSB. We are grateful for the dedication of the committee members and the staff and members we serve. What could have been a very difficult financial year, has given us reason to be optimistic for 2022, as we have exceeded in number and dollar amount the pledges of 2021. Thank you, our generous, thoughtful, prayerful members.

Throughout the year, we have seen God at work time and time again. The first way is with the efforts of Dave Thomas. Dave has gone far above and beyond the normal scope of work for this committee and it has been greatly appreciated by all. He spearheaded the Homeland Security Grant that funded new metal doors across the campus, perimeter fencing around the property, as well as increased lighting, all of which have increased the safety for all who attend FPCSB. Marilyn Kraft was instrumental in this effort handling all the paperwork! Additionally, Dave along with James Welte, have transformed Classrooms 1, 2, and 7 so they are ready for Oak Tree Learning Center to occupy in 2022. The Safe Reopening Committee was formed as a response to the Coronavirus Disease (COVID-19) Pandemic of 2019. Our goal is to provide recommendations of preventative measures to prevent the spread of COVID-19 to the operating ministries of First Presbyterian Church of San Bernardino.

We have witnessed God's care in providing us a trusted, caring and patient Committee. We have been provided the wisdom to keep flexible and adjust our recommendations with the ever-changing challenges of Covid-19. God has provided us signs of hope, a structure

of planning and a scaffolding for making safety practices real and concrete.

With the help of Marilyn Kraft, our we have developed and implemented a Code of Safe Practices for the specific operations of First Presbyterian Church of San Bernardino. This Code of Safe Practices allowed us to become a "Safe Business Partner" of San Bernardino County making us eligible for a \$5,00.00 grant. These funds allowed us to purchase masks, gloves and hand sanitizer. We have adjusted our food distribution to outdoor-only with the purchase of three easy-up canopies. We were able to help offset the cost of repairing and upgrading our HVAC system to the Sanctuary to provide the safest environment possible to worship in. Our Committee will continue to meet on a regular basis.

THEN... Easter outside in Magnolia Court and in person!! With the continuing careful and thoughtful guidance of the Safe Reopening Task Force we moved -in person- from Magnolia Court through Fellowship Hall and finally into the sanctuary on July 4th! There was more joy in welcoming the voices of first the sanctuary choir and finally the congregation when we all felt safe enough to sing.



Prepackaged communion elements (which we all agree that we intensely dislike) enable many of us to have communion TOGETHER in the sanctuary (which we all agree that we love). Even though we missed those of our family who still did not feel safe returning, we were tearful and joyful on August 1 as we celebrated our first in-person communion in more than 64 weeks.

Reformation Sunday was celebrated outside on the north lawn. This allowed our friends who still needed to keep a distance to join worship from their cars. Advent began with the theme of "The Inn" from The Worship Design Studio and asked us to make space for new things happening. Amy Gano and the Bell Choir brought more beauty to worship during the season and on the Sunday after Christmas.

Christmas Eve found us still together in person in the sanctuary and continuing our traditional candlelit "Silent Night" in the courtyard.

Throughout the year our William, Curtiss, Amy, and choir happily supplied a beautiful soundtrack to the services and they are beloved and appreciated. Thanks go to all those who recommitted to caring for the congregation through worship preparation and who remained cheerful and loving in spite of moving worship from place to place and not always knowing if, when, or where until sometimes the last minute. 2021 Personnel Committee Annual Report

The Personnel Committee members are Christa Wallis, Brooke Dvorak, Susan Skoglund and Amy Smith

The purpose of the Personnel Committee is to provide oversight and due diligence in dealing with all employment matters. These include, but are not limited to; recommending to Session hiring and the separation of church employees, except the pastor; conducting regular reviews of employee performance and recommending to Session salaries and/or raises or other benefits annually for all employees.

God has been at work as we recognize the dedicated and capable staff (and volunteers) that support this church and its various ministries. Several tasks that were accomplished include:

 Completing annual reviews for all paid staff by conducting oneon-one meetings (virtual this year) with all employees. These meetings are held after each staff member reflects in writing on their work responsibilities and accomplishments for the year.

- Recommending a cost of living adjustment of 5.9% to conform with the Social Security COLA - recognizing this Is not a raise rather than an effort to keep up with inflation.
- Recommending James' duties be expanded to include leading the live-streaming effort on Sundays with a salary increase accordingly.
- Held meetings as needed to discuss personnel concerns including coordination of vacation schedules to maximize office coverage, ensuring the Pastor's work schedule is flexible for her duties and revising staff position descriptions.

We are very blessed to have a staff with so many years of commitment to this church. In the past two years when there have been so many interruptions, they have continued in their duties and ensured the church's obligations and ministries continued in the best ways possible.

Internship Program 2021 Annual Report

The Internship Program continues to hire all of the interns through the LifeSkillz Program we have in partnership with San Bernardino High School. The pandemic created some difficulties, but we were still able to have the 3 terms we normally have each year. This brings the Internship Program to 16 terms since it started in early 2015.

The interns continued to help maintain the grounds here at First Pres, help with Food Distribution, make hygiene kits for our daily food giveaway and other tasks the church has ask of them. I think what is more important is we saw our interns grow in both their abilities and in confidence. There are now at least 6 interns from the 2021 terms who are working in other jobs they did not have when they came to the Internship Program. One of the goals of the Internship Program is to help our interns learn how to move on to their next job.

It is hard not to see God in this program. We have interns who would not even say "Hi!" when they pass in the hallways at school before becoming interns, now they are comforting each other when something is going wrong in their lives, recommending each other at their place of work and becoming such close friends that they go to the mall, to the movies and other places together.

God is in the simple sentence coming from one of our interns, "I don't mind pulling weeds."

It is so obvious to me that God has his hand in this ministry when former interns from 2 and 3 years ago contact us and want to know if they can help with Food Distribution. When you ask our former interns what they enjoyed the most, Food Distribution, helping their own community, is a common answer.

Our interns not only like the money they earn here, they love the church and how they are able to see what most of the areas they work on look like before they start and after they have finished. They like to see the fruit of their labor. This is something we make sure we call attention to. This ministry is a win/win, for both the church and for the young people who benefit from it.

Water Team Annual Report for 2021

Despite COVID-19, in 2021, the FPC Water Team core group of Jon Horstmann, David Grindahl and Mark Adelson continued to work on the project to provide clean water for Ilgesia Bautista Monte Horeb (IBMH), and its major mission, its school, Centro Pedagogico Didaque, in Tijuana's eastern suburb of Matamoros. Centro Didaque is one of the very few schools in all of Tijuana that serves special needs children from economically disadvantaged families, allowing parents to pay whatever tuition they can afford.

In 2021, the FPC Clean Water Team, and our clean water partners at Claremont Presbyterian Church, kept in contact with Centro Didaque continued to support their work. In early January, our Tijuana partners reported that the water treatment room had finally been finished and proudly sent videos of the final work. We were thrilled! But, because of the rapid spread of the COVID-19 Delta variant at that time, the team decided to delay a trip to build and install the clean water treatment system until later in the year.

Like teachers everywhere, Centro Didaque's teachers were doing their best to conduct classes on-line. In February, our partners at the school advised us that its teachers were frustrated by the poor performance of computers available to them at the school. The computers were obsolete, very slow and had been repaired many times, and were unstable when using the classroom software that was available. (Some of the students did not have access to computers, and they were coming to IMBH to use the school's computers to do their classwork.) The school's superintendent shared his staff's frustration over their computers with the Water Team and asked if the team could help get new computers for the teachers. After discussion, the FPC water team and the CPC water team each agreed to contribute \$2,000 toward for the purchase of 9 new laptop computers for the school. One of the CPC water team members acquired them, and early in March 2021, another of the CPC team delivered them to the school.

On the first weekend of November 2021, the FPC and CPC clean water teams travelled to the IMHB and begin the installation of the water treatment system. Finally! We made good progress with the installation but found that some components were missing (they were later located at FPC). The team members also briefly toured newly constructed classrooms at the school (funded by a significant contribution from a Canadian religious community) and observed the teachers using the school's new computers funded by the water teams from FCPSB and CPC. Another trip to IMHB is planned for February 2022, and with God's grace, the water team partnership will complete installation of the water treatment system, successfully test its operation, and train its operators. Treated water will be tested before the system goes into service. The system could be operational by March 2022, providing a reliable, abundant, wholesome source of clean

water to the students and staff of Centro Didaque and to the IMHB community.

Later this year (to be scheduled), the members of the FPC / CPC water team partnership will provide in-person instruction to the users of this clean water, using stories, songs, demonstrations and plays, to emphasize the clean water's best uses for drinking, preparing foods and beverages, oral hygiene, and washing babies.

God willing, we will accomplish this in 2022.

Other cards were mailed, phone calls were made and, in the brief openings during COVID lock downs, packaged shortbreads were distributed at Church, Memorial Service Receptions were carried out with precautions in place, meals were delivered to CCLM (served by their personnel). Girl Scout cookies (50 boxes), books, toys as well as clothing and other items were delivered to the Hospitality House for homeless families helped by the Salvation Army.

We met on Zoom all year and were able to break into committees, have guest speakers (including updates on closure by Dave Thomas) as well meet as a whole. Due to Zoom, Carol Valentine remained active after her move to Ohio. Also, Carmen Avila was able to attend some meetings from her Forestry assignments.

The Food committee made adjustments to Food Bagging and distribution including Drive Thru and storage relocation. More students in the intern program were able to help as older church members were restricted due to age and medical conditions as per COVID guidelines.

Each Deacon helped with the projects and we acted, in many instances, as a cohesive single committee as we navigated the altered circumstances. It was an opportunity to "think outside the box" and to work with mutual friendship and purpose.

The Deacons Food Ministry distributed 1,058 double-bags, 787 office bags, and 245 homeless (non-cooking) bags of food in 2021. USDA surplus and Feeding America food was transported to Church by many dedicated volunteers. Food bagging and drive-through distribution was mostly coordinated by Marilyn Kraft and Rick Rodriguez. Sadly, we lost our beloved, long-time Food Ministry leader Sally Morris in June.

The colossal amount of food handling and stocking was assisted by many Church members, students and graduates from San Bernardino High School, and Mountain Community helpers recruited by Neal Williams. Dave Thomas coordinated traffic safety and security at Saturday food distributions. The Rev. Dr. Stephen Smith supports this ministry in many ways, especially with spiritual guidance. For the many hands involved in this ministry, our committee and the Board of Deacons are very grateful.

Community Outreach Annual Report 2021

Community Outreach had a very good year despite COVID. Two outstanding dinners were delivered to CCLM. They requested that we just drop off the food and that they would serve it. When asked if the dinners were enjoyed, Claire (CCLM organizer) responded "They were terrific and how could we improve on perfection" They loved it and no leftovers!"

Girl Scout Cookies (53 boxes) were provided to the Salvation Army Hospitality house for the children. This benefited not only the Salvation Army children but also the Girl Scouts from our Church from whom we bought the cookies. We received thank you notes from each of them.

We also facilitated donations to the Salvation Army of toys, books, clothing, blankets, and household goods and have plans to do more as soon as COVID allows us on the premises to work with the children. The Director of the Hospitality House is going to speak to the Deacons in March to tell us more about the program and give us ideas about how we can best help.

Our Blood Drive was held on September 11, 2021, and produced 19 lifesaving units of blood with 4 donors from outside the church community participating.

All of this was accomplished with our committee of Janet McKinster, Rebecca Allen, Joanna Nord, Carmen Avila and Marianna Fowles (chair). Everyone had a great ideas and suggestions and enjoyed being a Deacon.
